**THIS IMPLEMENTATION AGREEMENT** is made:

**UNIVERSITAS AIRLANGGA** represented Prof. Dr. Dian Agustia, SE.,M.Si.,Ak. as the Dean Faculty of Economics and Business, Universitas Airlangga, based on Rector's decree No. 831/UN3/2020 dated 30 September 2020, whose address is at Jl. Airlangga 4-6 Surabaya, Indonesia.

**AND**

**CAN THO UNIVERSITY**, represented by Dr. Phan Anh Tu School of Economics CAN THO UNIVERSITY, whose address is at Khu II, Đ. 3/2, Xuân Khánh, Ninh Kiều, Cần Thơ, Vietnam.

(Hereinafter referred to singularly as "Party" and collectively as "Parties").

Whereas:

- A. The parties are desirous of entering into this Implementation Agreement to declare their respective intentions and to establish a basis of cooperation and collaboration in academic interest, between the parties upon the terms as contained herein.
- B. Faculty of Economics and Business, Universitas Airlangga covers study programs as follows:

The purpose of this Implementation Agreement is to establish the legal framework for cooperation between two parties, in concordance with Sustainable Development Goals (SDGs), specifically for the theme of Quality Education, Decent Work and Economic Growth, and Partnership to Achieve The Goal.

**THE PARTIES HAVE REACHED THE FOLLOWING UNDERSTANDING:**

Article 1

**1. SCOPE AND FIELDS OF COOPERATION**

1. Organizing student exchange and student mobility in the form of a student forum activity.
2. Organizing staff mobility program by doing collaboration in research and academic activities.

2. **CONTRIBUTION OF THE FACULTY OF ECONOMICS AND BUSINESS  
UNIVERSITAS AIRLANGGA**

1. Arrange the intended activities (student and staff mobility activities) according to the schedule.

Article 3  
**CONTRIBUTION OF Dr. Phan Anh Tu  
CAN THO UNIVERSITY**

1. Conducting a student forum for student mobility activity and guest lectures for a staff mobility activity on the scope of the Faculty of Economics and Business.

Article 4  
**FINANCIAL RESPONSIBILITIES**

1. The Faculty of Economics and Business Universitas Airlangga is responsible for covering remuneration according to Indonesian standard for inbound staff mobility.
2. The Faculty of Economics and Business Universitas Airlangga is responsible for covering local transportation, meals and Business Visit according to Indonesian standard for inbound student mobility.

Unless otherwise stated, this agreement does not constitute or create, and will not be deemed to constitute any legally binding or enforceable obligations on the part of either Party unless and until an agreement regarding each objective is negotiated, approved, executed and delivered by the Parties.

SIGNED IN DUPLICATE in identical copies in English and Bahasa Indonesia by the authorised representative of each university, the two texts being equally valid. In the event of any divergence of interpretation between any of the texts, the English text shall prevail.
