



MEMORANDUM OF UNDERSTANDING

Between

BUSINESS ADMINISTRATION, KANGWON NATIONAL UNIVERSITY, REPUBLIC OF KOREA

This Memorandum	of Understanding	(after this	referred	to as the	"MOU")	is made and
entered into as of	(after	r this refe	red to as	the "Effe	ctive Date	") between:

School of Economics, Can Tho University (from now on referred to as "SOE.CTU"), a public institution of higher education whose administrative office at Campus II, 3/2 Street, Xuan Khanh Ward, Ninh Kieu District, Can Tho City, Viet Nam, herein represented by Prof. Dr. LE KHUONG NINH, Rector of SOE.CTU is one of the leading higher education institutions at Can Tho University, Viet Nam. It operates its resources to make significant contributions to developing high-quality human resources and advancing science and technology to cater to regional and national socio-economic development.

and

KANGWON NATIONAL UNIVERSITY, ROK, (hereinafter referred to as "KNU"), a university/professional/research centre whose address is at 1 Kanwondaehak-gil, Chuncheon-si, Gangwon-do, 24341 Republic of Korea and shall include its lawful representatives and permitted assigns

Both parties are interested in establishing a relationship that will promote cooperation and exchange in education and research between the two parties agree as follows:

- 1. Based upon the principle of respect for each other's independence and mutual benefit, the parties will carry out the following programs:
 - (1) Exchange of professors, lecturers, research scholars, and staff members;
 - (2) Exchange of undergraduate and graduate students;

- (3) Exchange of scientific materials, publications, and other information of mutual interest;
- (4) Collaborative activities include joint research, symposia, and conferences.
- 2. To carry out any of these programs, detailed provisions of each program shall be developed and agreed upon in writing by both parties.
- 3. This MOU shall impose no financial obligations on either party.
- **4.** This MOU shall become effective on the date of signing by the representative of both parties and shall remain in effect for five (5) years. After that, this MOU will be automatically renewed for an additional five years unless either party provides written notice of termination at least six months before the termination date.
- **5.** This MOU is made in two identical copies written in English. The parties will sign each document and retain an original copy.
